| exchange for consideration described herein under "Fee Scheduled for Services Rendered." All fees are collected to |
| offset administrative management costs (dispatcher) as well as Shipping and Handling costs. |

Scope and Manner of Services

Services to be rendered by The Provider:

The Provider agrees to make available access for temporary use, one (1) Metal Transporter Dealer Plate with full insurance and registration for the purpose of transporting authorized vehicles. The Contractor will assume all ancillary charges incurred when using these plates and will pay them promptly (parking tickets and tolls, etc.). The Provider maintains full control of Transporter Plates at all times, and can be re-called immediately if it is suspected that plate is being used in an illegal manner i.e. unauthorized personal or other unrelated business usage (i.e., using the plate to transport cargo, deliveries, or passengers for pay, etc.)

Fee Schedule

Monies will be collected by The Provider at the following schedule unless otherwise noted:

Weekly Fee (for 7 Days or 168 hours)

\$250 (includes overnight delivery and pre-paid return mail pouch) + \$200 refundable deposit\$55 Daily late fee

Daily Fee (for 3 Days or 72 hours)

\$150 (includes overnight delivery and pre-paid return mail pouch) + \$100 refundable deposit

\$55 Daily late fee

This fee schedule is for current members of our Dealer Agent Network. All others will be assessed a \$250 Security Deposit (refundable) before the Plate is released or delivered.

<u>Note</u>: The Provider has no claims on any other funds generated by the Contractor in connection with using these Transport Plate other than what is described in Payment Schedule.

All Funds will be collected in advance from Client via Bank of America, Wellsfargo, Paypal or Cash Square App, Debit/Credit Card (or cash currency). Any funding other than cash is subject to 3% transaction processing fee.
